The Safe Kids Denver Metro coalition (SKDM) was established in 1998 in a formal agreement with the National SAFE KIDS campaign (currently known as Safe Kids Worldwide). The coalition is led by The Children's Hospital, and overseen by a Coalition Coordinator and Leadership Team. The Leadership Team is made up of officers, who represent the members of the coalition.

The Safe Kids Denver Metro coalition is a partnership of agencies, businesses and individuals with a common mission of reducing preventable injuries in children. It draws its membership from agencies including hospitals, healthcare, police, fire, paramedic and other public organizations, parent groups and private individuals. The Coalition is one of over 300 coalitions and chapters from across the United States that work with the Safe Kids Worldwide, a nonprofit program of the Children's National Medical Center, based in Washington, DC.
